



Registration Information

Continuing student priority registration: Begins June 8

Lottery registrations are being accepted June 8th – 20th for students that participated in the full 2008/2009 school year. Registrations may be mailed or dropped in the registration drop box at the Highland Park office, with a \$300. deposit per class. Students must register for the class level stated on the student evaluation. If adding a class, and are unsure of the appropriate level, please contact the Director or Assistant Director.

Summer student priority registration: Begins June 22

Lottery registration begins June 29th for students enrolled in the summer session 2009 of classes, camps, workshops, or Intensive Study Program. Please check with the dancers' instructor regarding level placement for the fall. Registrations may be mailed or dropped in the registration drop box at the Highland Park office, and must include a \$300. deposit per class.

New student registration: Begins June 29th

Walk in and mail in registration begins June 30th for new students or returning students that did not attend classes as of January 1, 2009 at the North Shore School of Dance. Registrations may be mailed or dropped in the registration drop box at the Highland Park office, and must include a \$300. deposit per class. If you do not find a class that fits your schedule, please contact us at 847.432.2060.

Payment Plan Options:

Option 1: Registration for 1 – 2 classes

\$300 deposit per class. Balance of tuition due in 2 equal payments: October 15th and December 15th.

Option 2: Registration for 3 – 7 classes

\$300 deposit per class. Balance of tuition due in 4 equal payments: October 15th, November 15th, January 15th, and February 15th.

Option 3: Payment in Full with discount

2 – 4 classes 5% discount with payment in full by October 15, 2009.

5 – 7 classes 10% discount with payment in full by October 15, 2009.

** Any discount applied at registration can be withdrawn if the student does not maintain the necessary amount of classes required.*

Dancers must remain enrolled from September through May.

Option 4: Unlimited Class Payment Plan

A dancer taking a minimum of 8 dance classes per week are eligible for the Unlimited Plan. Dancers must remain enrolled from September through May.

All Spring Concert costume fees will be combined into your tuition and divided into monthly payments.

Unlimited Discount Plan fee: \$1,000. deposit, \$525. per month payment (September – April)

Refund and Credit Policy:

All requests for withdrawing from class(es) must be put in writing to be considered. A doctors note is required for medical problems.

Requests are only considered from date received.

Terms are as follows:

Drop 1 - 14 days from the first class, \$20.00 charge per class held, plus a \$25.00 withdrawal fee per class.

Drop 15 - 30 days from the first class, 75% tuition refund plus a \$25.00 withdrawl fee per class.

Drop 31 - 45 days from first class, 50% tuition credit plus a \$25.00 withdrawl fee per class.

Drop 46 - 60 days from first class, 25% tuition credit plus a \$25.00 withdrawl fee per class.

After 60 days, no credit will be given.

Tuition credit is kept on account for one year.
